Call to Order –

- 1. Fran Kuhn called the meeting to order at 10:01 am.
- 2. Approval of minutes from June 2024. Motion, Monica Mulligan, Paul Grzella, Second. All Approved

Danielle Jubanyik - Literacy Update

- 1. Changes to the funding for Literacy.
- 2. Typically, the allocations would go to each local area to fund the Learning Links. Since we are not getting additional funding from the State, and there is some waste seen throughout the State post-COVID the State will be issuing an NGO.
- 3. All areas can apply for this funding.
- 4. 12 Areas did apply for no-cost extensions. Must obligate by September 30 and spend down the funds by December 31, 2024. If you are looking to reallocate funds, or change the budget, must send in a modification to your budget to Jon Cohen and copy Danielle.
- 5. There will be a mandatory Technical Assistance meeting where all WDB's should be in attendance.
- 6. Local areas can braid funding to keep their Links going.
- 7. WDB's only can apply for the NGO. There will be one award per region.
- 8. For those areas that spent all of their funds, there are no funds available to bridge the gap.
- 9. Aztec software will no longer be available. Awardees will have their choice of software and their objectives (GED teaching, digital literacy, etc.).
- 10. Secret shoppers went out to every Learning Link and saw that they were not used.
- 11. All equipment will be lost by December. The equipment is the property of NJDOL.
- 12. Title II received an increase in funding.

Melissa Moody and Sherie Jenkins – Work First New Jersey Update

- 1. There will not be a statewide letter sent. The CSSA's are to send out letters for outreach this is in the DFDI. All local areas have been informed.
- 2. The Work First NJ website has been updated and clients can go there to review responsibilities. This is federally mandated, locally provided services.
